These measures include cohorting of students, directional signage for passing between classes, lunch schedules that include eating outdoors, and signage within the schools to promote physical distancing.
Handwashing and respiratory etiquette	Y	Heritage Academy Schools encourages and reinforces <u>handwashing</u> with soap and water for at least 20 seconds, or as appropriate, use of hand sanitizer that contains at least 60% alcohol after bathroom use, before and after lunch and at other appropriate times during the day. Heritage Academy Schools support <u>healthy</u> <u>hygiene</u> behaviors by providing adequate supplies, including soap and hand sanitizer. Additional hand washing stations were installed in the lunch area and sanitizing stations have been installed in the school facilities. Heritage encourages staff and students to cover coughs and sneezes and follow hand-hygiene protocols.

(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
